How your Leisure Card works

What is a Leisure Card?

The Leisure Card entitles residents to a discount of at least 10% on the cost of sporting and fitness activities at any of the five leisure centres provided by St Albans City & District Council.

Residents will also qualify for discounts on standby tickets at venues such as the Alban Arena and Harpenden Public Halls.

Who can apply?

The Leisure Card is available to everyone living in St Albans City & District.

What are the benefits for residents?

- 10% discount on all adult non resident pay and play activities.
- 10% discount on all membership packages.
- Children and young people aged 18 and under receive a 50% discount on the adult pay and play activities.
- 50% discount on the adult pay and play activities for residents in receipt of:
 - Income support
 - Housing and council tax benefits
 - Job seekers allowance
 - Working families tax credit
 - Incapacity benefit
 - Pension credit (guaranteed element) 60yrs+
 - Full time students over 18
 - Employment Support Allowance

Applications from Elite Sports People

To qualify for FREE access to pay and play activities, resident elite sports people need to contact St Albans Arts, Sports and Health Development Team for a Pursuit of Excellence application form (01727 827667). Applicants will be expected to supply references confirming their sporting standard and proof of residency.

- Elite sports people receive free access to pay and play activities including access to their individual sport, health and fitness, swimming and group exercise. To qualify, juniors need to have been selected for a county squad or above, adults for a national squad.
- Half price standby tickets for events at the Alban Arena and Harpenden Public Halls (when available).

How do I apply?

Fill in the application form on this leaflet and hand it in at any Leisure Centre with proof of identity. You will then be issued with your card. Your photo will also be taken to ensure that cards are used only by the cardholder.

Residents need to renew their card annually free of charge by completing a new application.

What happens if my card is lost or stolen? One replacement card will be issued free of charge. Subsequent replacements will cost £5.00.



What proof of identity do I need?

To apply for:

10% residents' discount on pay and play, and membership packages.

ID required:

Two proofs of identity (one must include current address) ie council tax bill, driving licence.

50% children and young people's discount (18 and under) Or free swimming for under-fives.

Birth certificate plus parental proof of address.

50% concessionary discount for residents in receipt of:

- Income support
- Housing and council tax benefits
- Job seekers allowance
- Working families tax credit
- Incapacity benefit
- Pension credit (guaranteed element) 60yrs+
- Full time students over 18
- Employment Support Allowance

Exercise Referral Scheme

The exercise referral scheme is designed to support residents with health conditions where physical activity can aid recovery or improve quality of life. Applicants need to contact St Albans Arts, Sports and Health Development Team for an application form (01727 827667) and information on discounts available for this scheme. Applicants will be expected to supply a referral letter from a health professional as well as proof of residency.

Remember to bring your identification as Leisure Cards cannot be issued without it.

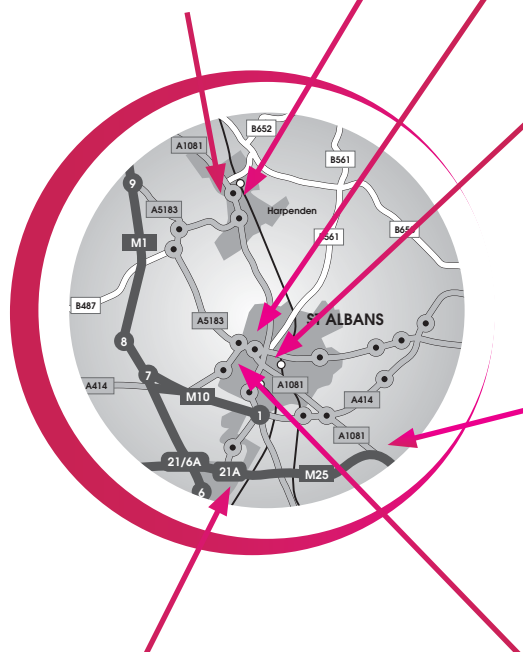

Leisure Card Terms and Conditions

1. The Leisure Card is at all times the property of St Albans City & District Council and Leisure Connection Ltd and must be surrendered on demand.
2. The Leisure Card is not transferable and must be used only by the person for whom it was issued. If transferred it will be forfeited.
3. All changes to personal details must be disclosed to Leisure Connection Ltd.
4. Leisure Connection Ltd reserves the right to refuse to issue or renew the Leisure Card.
5. The Leisure Card must be available for inspection at any time. If it cannot be produced or is in any way not valid the full price for the activity must be paid without right of refund. If required, customers must sign their name as proof of identity.
6. Any loss of the Leisure Card shall be reported immediately to Leisure Connection Ltd.
7. Any breach of these conditions will render the Leisure Cardholder liable to forfeiture.
8. Completion and signature of the Leisure Card application form will be held to constitute acceptance of these conditions including the requirement for a photograph.
9. Concessions may not apply in the following circumstances:
 - i) Group bookings or room hire
 - ii) Sports Pitches
 - iii) Other items as specified in the published price lists
10. Facilities may be withdrawn or restricted from time to time to perform essential repairs and refurbishment. Where possible two weeks notice will be given. Other facilities in the City and District may provide the same or similar facilities.
11. Sessions may be limited over Christmas and other holiday periods.
12. St Albans City & District Council and Leisure Connection Ltd reserves the right to withdraw the Leisure Card scheme at any time.
13. St Albans City & District Council and Leisure Connection Ltd reserves the right to alter the programme of activities at the Centres.
14. Use is subject to bookings and availability.
15. These Terms and Conditions are subject to amendments from time to time..
16. All pay and play activity discounts are calculated from the adult resident pricing policy.
